	has the right to use the recreational facilities as a guest of Bradley Forest Recreation Association for this day only.
	Appearer understands fully that the Bradley Forest Recreation Association, its Officers and Directors, does not take

for the enforcement of any rules or warnings which may now of hereafter be posted at the facility.

- 2. In the event that appearer, appearer's family or invitees does suffer personal injury or property damage, then the appearer, on his/her own behalf and on the behalf of appearer's family, and invitees does hereby fully release and hold harmless as qualified hereinafter, Bradley Forest Recreation Association, its Officers and Directors, in connection therewith and does agree to indemnify Bradley Forest Recreation Association, its Officers and Directors, in connection with any claims which might be asserted in connection therewith, only to the extent that any such claim is not covered by any applicable insurance issue to Bradley Forest Recreation Association, its Officers and Directors. Subject to the foregoing limitation, this indemnity shall obligate appearer to reimburse Bradley Forest Recreation Association, its Officers and Directors, for any damages and/or costs which might be awarded in connection with any claim made by appearer's family or invitees, or made as a result of the actions of appearer, or appearer's family, or appearer's invitees, together with legal fees incurred by any of the parties or companies herein held harmless with defending claim.
- 3. Appearer, for the benefit of appearer and that of the appearer's family and invitees does hereby voluntarily waive any and all rights which the appearer, appearer's family and/or invitees may otherwise have had, in connection with any personal injury or property damage, to proceed against Bradley Forest Recreation Association, it's Officers and Directors, so that in the event that they is any injury to any person or damage to property on the grounds on site of the recreational facility, then no suit shall be filed against Bradley Forest Recreation Association, its Officers and Directors, in recognition of the fact that all liability of every description in connection with the use of the premises/facility is to be borne by those who elect to use the facility.
- 4. In executing this Release, Hold Harmless and Indemnity Agreement, appearer, acknowledges that minors under the age of sixteen (16) years of age are not allowed to utilize the recreational facilities without having parent on site for the purposes of supervision and the said appearer shall at all times be responsible for the actions of the child.
- 5. Appearer acknowledges that this Release, Hold Harmless and Indemnity Agreement are given after reading the whole of this document and the appearer has voluntarily executed this Release, Hold Harmless and Indemnity Agreement, and assumes full and complete responsibility for the use of this facility by appearer, appearer's family and invitees.
